- 1. The payment account for basic transactions is a payment account in BGN.
- 2. The fees for Cash withdrawal from another PSP's ATM abroad, Payment at POS terminal with debit card within EEA and outside EEA, Balance check up with debit card at ATM within EEA and outside EEA shall be applicable for cards, issued until 31.08.2023 with level "J" in accordance with the published Level of limits.
- 3. In cases of "BPA, under the terms of Art. 120a, LPSPS":
- the services shall be provided free of charge with the exception of those for Opening and Cash withdrawal from another PSP's ATM in Bulgaria;
- for operations with funds out of the scope of Art.120a, LPSPS, the Bank shall apply fees, stated above, in the month following the reporting month;
- in case of applied fees for direct debits or standing orders, they shall be refunded
- 4. For all other banking services and transactions, executed through the payment account for basic transactions, shall be applicable the fees and commissions in the relevant chapters of the Fibank's Tariff.
